#### I. Old Business

### III. Treasurer Report

Carol will check with Priscilla regarding the \$1000.00 promised from KY Thoroughbreasts Festival last year. The coaches have been paid for the June paddling clinic, Carol will forward the coaches air fare bill to Lisa.

## IV. Fundraising Report

Ellen states that Alison could not find her receipts for items purchased for The Cure fundraiser. She will keep the money earned from the specialty drinks and we will call it even. She understands that she cannot be repaid without receipts. Ellen and Lisa will work on a plan for disbursing moneys earned to DCD members going to Italy in 2018.
